Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the <u>plan</u> , each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
Are there services covered before you meet your deductible?	Yes. Office visits, preventive care services, diagnostic tests, emergency room care, emergency medical imaging tests, transportation, urgent care, outpatient mental health, outpatient substance abuse, and prescription drug benefits are covered before you meet your network deductible.
